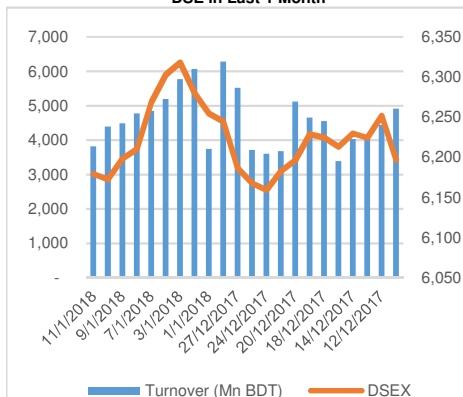

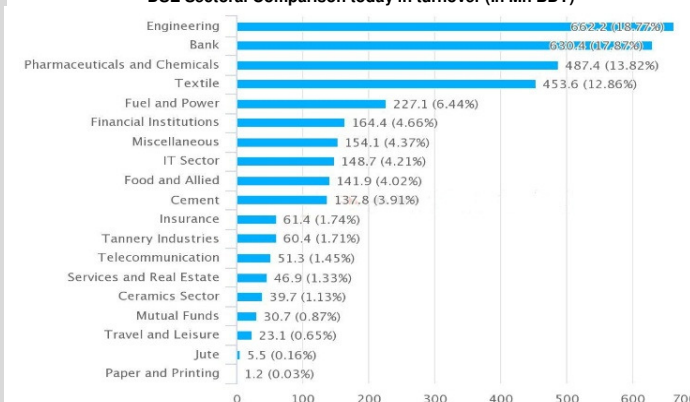

Market Commentary

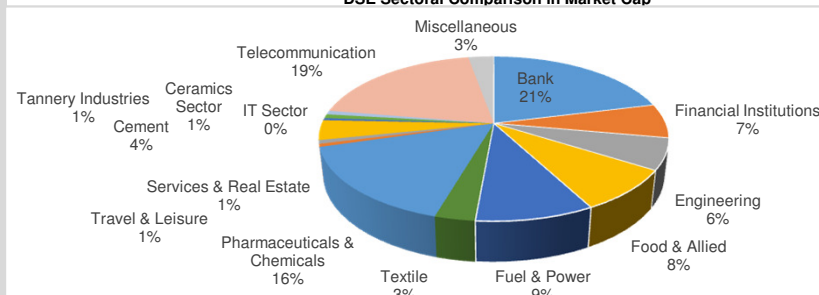
